

IMPORTANT NOTICE

As required by the Code of Virginia, the County of Rockingham has removed from the list of registered voters, any person who did not take action in response to an official request for confirmation of their address within the time allowed by law. Any person named on this list has been deleted from the voter registration records and is ineligible to vote pursuant to Virginia Code 24.2-428.2, which is attached.

If you feel you have satisfied the requirements of 24.2-428.2 of the code, you must contact the General Registrar's Office, listed above, to confirm your eligibility to vote. The office hours are Monday through Friday, 9:00 a.m. to 5:00 p.m. If your name appears on the attached list, you are, at this time, considered ineligible to vote.
