Election Officer Term of Office Beginning in the Year 2020: After brief discussion regarding the challenges faced by the Registrar's Office to receive oath forms in a timely fashion from officers wishing to serve, a motion was made by Trish Philon, seconded by Susan Threewitts, and unanimously carried, to extend the term of

office for election officers from one year to three years. This action will begin with the March 1, 2020 through February 28, 2022 election cycle.

Election Officer Pay: After brief discussion, a motion was made by Susan Threewitts, seconded by Trish Philon and unanimously carried, to increase the base pay for election officers (excluding Central Absentee Precinct—CAP) from \$160 per day to \$175 per day, effective July 1, 2019.

Registrant Count: It was noted that there are 50,074 registered voters as of this date.


Upcoming Events: Primary – June 11, 2019 (if requested); training date for the primary will be Monday, May 20, with the Electoral Board meeting at 5:30 PM to meet with Chiefs for ballot counting; and distributing election materials and equipment to be held June 10 (Board of Supervisors Room) from 11 AM until 3 PM.

Absentee Voting: Lisa Gooden noted that with the increased number of absentee voters, the Board of Supervisors' Room has been reserved for a three week period in the fall to accommodate absentee voters at that location.

Precinct of the Year: After discussion, a motion was made by Susan Threewitts, seconded by Trish Philon and unanimously carried, to name **306-Cross Keys** as the **Precinct of the Year for 2018**. In November 2018, Wayne Pence served as Chief; Dorenda Flick, Assistant Chief; and Election Officers Kimberly D. Mickelson, Sherrill Hood, and Lynette Michael.

The meeting adjourned at 10:30 a.m. The next meeting will be held on March 5, 2019, beginning at 9:30 a.m. in the Voter Registrar's Office.
