The **April 16, 2019** meeting of the Rockingham County Electoral Board was called to order by Board Chair Linda Shuler. Electoral Board members attending the meeting were: Linda Shuler, Chair; Trish Philon, Vice Chair; and Susan Threewitts, Secretary. Also in attendance was Rockingham County Director of Elections, Lisa B. Gooden.

The purpose of the meeting was to conduct Logic & Accuracy (L & A) testing for the June 11, 2019 primary.

Approval of Minutes: A motion to approve the minutes of March 18, 2019 was made by Trish Philon, seconded by Susan Threewitts, and unanimously carried.

Ballot Order for June Primary: The ballot order for the June 11, 2019 Primary was discussed. A motion was made by Susan Threewitts, seconded by Trish Philon, and unanimously carried, to order 75% of voters for the Democratic Primary (26th House of Delegates District) and 77% for the Republican Primary (24th Senate District).

Five precincts will not be included: 105-Lacey Spring, 106-Tenth Legion, 107-Plains, 405-Ottobine, and 406-East Bridgewater. There will, however, be a dual primary in 301-Keezletown and 505-Stony on June 11.

Ordinance for Polling Places for 103-Fulks Run and 108-Little North Mountain: Board members were apprised that an ordinance was approved by the Board of Supervisors on April 10, 2019, to officially relocate 103-Fulks Run to Chimney Rock VFW Post 9660 and to relocate 108-Little North Mountain to J. Frank Hillyard Middle School. (Refer to the attachment)


ELECT Security Training: It was noted that the Director of Elections and a member of the County's IT department will be attending a Tabletop Security

SECTION 6A-6
OF THE CODE OF ORDINANCES
OF
ROCKINGHAM COUNTY, VIRGINIA

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF ROCKINGHAM COUNTY, VIRGINIA:

That Section 6A-6 "Precincts and polling places -- Establishment and authority" pertaining to Election District No. 1 be and hereby is repealed and re-enacted as follows:
