The **November 6, 2019** (Canvass of Votes) meeting of the Rockingham County Electoral Board was called to order at 9:30 a.m. in the Recreation Department's conference room by Linda Shuler, Chair. Electoral Board members attending: Linda Shuler, Chair; Trish Philon, Vice Chair; and Susan Threewitts, Secretary. Also in attendance was Director of Elections, Lisa B. Gooden.

Precinct of the Year: After brief discussion, the Board named **105-Lacey Spring** as the **Precinct of the Year**. Officers serving for the November 5, 2019 General Election for that precinct included: Debbie Callahan, Chief; Sandy Goodman, Assistant Chief; and Deborah Vance and Regina Phillips, officers. These individuals will receive the coveted red, white and blue umbrellas with the county logo.

Also, the Board agreed that **401-West Bridgewater** would be the runner-up for Precinct of the Year for 2019. Officers serving included: Susan Pollard, Chief; Sara Walton, Assistant Chief; and Charles Chevalier and Sandra Cline, officers. These individuals will also receive the coveted red, white and blue umbrellas with the county logo.

The Board agreed that 2019 would conclude naming of a Precinct of the Year award as the performance of officers at the precincts had consistently reached its peak over the past several years, making it difficult to select only one precinct.

Ballot Order for March Democratic Party Presidential Primary: After brief discussion, a motion was made by Susan Threewitts, seconded by Trish Philon, and unanimously carried, to set the ballot order at 60% of the total registered voters for the March 3, 2020 Democratic Party Presidential Primary.

Logic and Accuracy (L & A) Testing for March Primary: After brief discussion, the Board agreed that tentative dates for the L & A will be January 7, 8, or 9, whichever date the vendor (ESO) is available.

Election Officer Training for March 3, 2020 Primary: A tentative training for the March primary will be held during the third week in February.

Rockingham County Security Plan 2020: After brief review, a motion was made by Trish Philon, seconded by Susan Threewitts, and unanimously carried, to approve the Security Plan for 2020.

Canvass of Votes for November 5, 2019 Election: Members opened the Canvass of Votes by first reviewing the 1A Provisional Votes cast. Following, a review of each precinct's election summary tapes and envelopes was conducted.

Members recessed the meeting at 5:00 p.m.

The Canvass of Votes reconvened at 11 a.m. on Friday, November 8, with all members present.
