



The November 4, 2020 meeting of the Rockingham County Electoral Board was called to order at 9:30 a.m. in the Recreation Department Conference Room by Board Chair Trish Philon. Electoral Board members attending the meeting included: Mike Auchard, Trish Philon, Susan Threewitts. Also attending: Rockingham County Director of Elections, Lisa B. Gooden. Observers included: Andy Banks, Jeff Roadcap and Joan Hughes.

Minutes: A motion was made by Susan Threewitts, seconded by Mike Auchard and unanimously carried to approve the minutes of September 14, 2020, as presented.

Canvass of Votes for November 3, 2020 General and Special Elections: The Canvass of the November 3, 2020 election began.

Provisional ballots cast were reviewed and noted on the Master Log and for future reference.

The meeting was recessed at 4:30 p.m. until November 5.

The Board reconvened at 9:30 a.m. on November 5 and continued with the Canvass of Votes, concentrating on Envelope 2 and checking the SOR's for signatures and mathematical errors.

Due to the change in State Code to allow ballots postmarked on or before November 3 to be received until noon on Friday following the election, the board recessed at 6 p.m. and agreed to reconvene on Friday.

The Board reconvened at 1 p.m. on Friday, November 6, to finalize the canvass, including Central Absentee Precinct (CAP) totals and provisional ballots.

The Board recessed until November 9 at 3 p.m. and certified the election according to the Abstract of Votes (as noted on the following pages) for the

November 3, 2020 General and Special Election.
