



The Rockingham Electoral Board began the Canvass of Votes for the November 5, 2024 General and Special Elections at 9:30 A.M. on Wednesday, November 6, 2024, in the Registrar’s Office Annex, 20 East Gay Street, Harrisonburg.

Attendance: David K. McQuilkin, Chair; Rebecca Ruckman, Vice Chair; Susan C. Threewitts, Secretary; and Daryl Borgquist, Republican Party Chair. Staff from the Voter Registrar’s Office periodically entered the meeting, as requested.

Canvass of Votes: It was noted that absentee ballots received by mail and postmarked on or before November 5, 2024 may be received until noon on Friday, November 8, 2024, and will be processed by the Central Absentee Precinct (CAP) team prior to the Board’s review.

Provisional Ballot Meeting and Same Day Registrations: It was noted that a total of 1,185 Same Day Registrations (SDRs) were received for this election. Members of staff were diligent in working through these and were in frequent contact with ELECT noting that it would be a tall task to meet the deadline for completion. 
