



The **November 5, 2025**, meeting of the Rockingham County Electoral Board was called to order at 9:30 a.m., by David K. McQuilkin. The purpose of the meeting was to conduct the Canvass of Votes for the November 4, 2025 General and Special Elections.

Attendance: Electoral Board members present included: David K. McQuilkin, Chair; Rebecca Ruckman, Vice Chair; and Susan C. Threewitts, Secretary. Also attending: Lisa Gooden, Director of Elections; Emily Helms, Chief Deputy Director of Elections; and Maddie Paladino, Deputy Director of Elections.

Others attending throughout the Canvass included: Daryl Borgquist, Republican Party Chair; Jennifer Aulgur (Senator Mark Obenshain's Aide); Chad Funkhouser (Delegate Tony Wilt's Aide); and other representatives for Andrew Peyton (candidate for House of Delegates.)

Approval of Minutes: A motion was made by Susan Threewitts, seconded by Rebecca Ruckman, and unanimously carried, to approve the minutes of September 15, 2025, as presented.

Appointment of Election Officers: A motion was made by Susan Threewitts, seconded by Rebecca Ruckman, and unanimously carried, to appoint the following individuals as election officers effective immediately through February 28, 2027:

Canvass of Votes for November 4, 2025 General and Special Elections: Members proceeded with the review of Envelopes 2, 2A, and 7. During the Canvass, there was also discussion about formal complaints filed regarding the 101-Broadway precinct—issues with campaigners and the difficulty a voter experienced in trying to get past the campaign area to walk inside the polling location to vote; social media posts regarding food being provided to voters, to name a few.

Members of the Board agreed that the layout of this precinct does raise concerns, especially since there is a thru street that is close to the prohibited area and a portion of the parking lot is sloped. After some discussion and a phone call to Steve Reid, Maintenance Director for Rockingham County Public Schools, members agreed to set up a meeting to tour Broadway High School as a potential place to relocate this polling place in the future (especially if the large commons area of the school could be used for this purpose.) Lisa Gooden will also respond to this concern via email.

Another precinct concern was about the number of political signs that were placed at 306-Crossroads. Lisa Gooden said she would respond to the concerns mentioned but said it is difficult to manage this type of occurrence for 29 precincts.


